This trial is the day before stock finals.

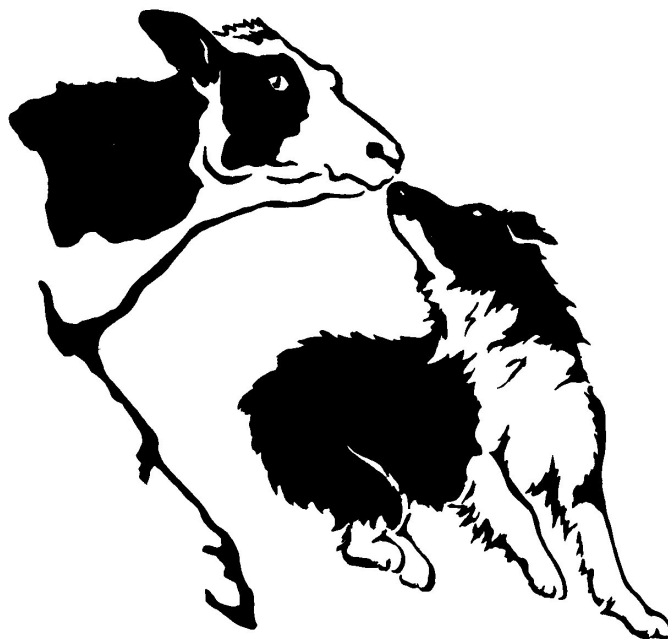
**All entries postmarked on the opening date will be guaranteed runs!**

Handler's meeting starts at 7:30am and trial starts promptly at 8:00am. Run order will be drawn after the closing date and sent out in confirmation letters. Handlers with multiple dogs will be separated as well as possible to allow time to exchange dogs between runs. There will be a set run order and dogs will be expected to run at their assigned time. If a handler has a conflict, they must notify the Course Director ahead of their assigned run time.

Course A will be run on all stock types - 5 head will be run for each stock type.

DIVISIONS: Advanced, Open, Started, Novice Handler, and Working Junior Handler.

## AWARDS:

Including but not limited to:

Ribbons for 1<sup>st</sup> – 4<sup>th</sup> place in each class. Ribbons for qualifying scores.

Silver Belt Buckles for High Combined Advanced, Open and Started.

High Combined Aussie Awards– Silver belt buckle given for the highest combined score by an ASCA-registered Australian Shepherd for the trial in Started, Open and Advanced classes. Dog must be competing at the same level in all three stock types to be eligible for the award at that level. The three scores, one each from cattle, sheep and ducks for a dog will be used to determine their combined score. Scores cannot come from an FEO run. Non-qualifying scores will be

counted. In the event of a tie, the dog with the highest cattle score will win. If the cattle scores are tied, the dog with the lower time on cattle will win.

**Make checks payable to FCASC. Mail Entries to Allison Bryant, 912 Four Mile Church Rd, Ball Ground, GA 30107. Entries must not be postmarked prior to July 15th, 2010.** All entries received with a July 15th postmark will be guaranteed runs. Additional judges will be added if entries warrant. A wait list will be maintained for entries postmarked after July 15th. **Do not mail entries requiring a signature for receipt!**

If using **PayPal or Credit Card** to pay your entries, go to the club website at [www.fcasc.com](http://www.fcasc.com). Follow the instructions on how to pay for entries. Print out your receipt and include a copy of it with your entries.

“THIS AND THAT”

- ALL ASCA Rules and Regulations will be enforced.
- All entries must be on an official ASCA entry form. Forms can be downloaded from [www.asca.org](http://www.asca.org), go under ‘forms’.
- Bitches in season will run in order drawn.
- Individuals will be responsible for any damage done to the stock and/or equipment.
- Entries will not be refunded for any reason after pre-entries close (September 7th, 2010). Substitutions of another dog you own will be allowed.
- Please notify the Course Director of move ups as soon as possible.
- TRIALING CAN BE INHERENTLY DANGEROUS. Therefore, an individual is responsible for any damage done to or by himself, his family, his visitors and his dog, both on the premises and in the trial arena. ASCA, FCASC, Michael and Allison Bryant and Sue Graham and members of their family and members of the FCASC assume no responsibility for any accident or injury.
- All dogs MUST be on leash when not competing. This includes dogs that handlers don't think need leashes!
- Pick up after your dogs.
- All attendees are required to have fun!
